Robbie Dawson, IFMA Board Member: Reported on the International Fire Marshal's Association

- There have been testing and test burns on energy storage system.
- The board is also working on high-rise wood frame structures being constructed.
- An NFPA Technical Committee is being established for hazardous waste generation.
- Alarm and security committees discussing active shooter situations and how systems interface with building components (doors, etc.)
- Standards coming on mobile cooking operations.
- Standards on mobile fuel dispensing and Uber Fuel Trucks
- Marijuana issues out west.
- Encouraged people to get involved with NFPA committees and let the VFPA leadership to recommend you for appointment to the committee you're interested in.

Ron Farr, *Underwriters Laboratories*:

- UL continues to acquire companies that do testing and validation of clothing and fabrics.
- Getting involved in green/energy activities.
- Benistration, dealing with testing of energy conservation materials.
- Fire Safety Research section continues to work on projects. They are doing lots of data gathering on past tests and research. Can go to fire research section on the UL website.
- UL is working with foreign countries on inspections of existing buildings for building maintenance fire safety.
- Hover boards have not been listed but they now have one listed hover board that has been approved.
- UL 217 is changing to hopefully reduce false activations, etc.
- UL Product Spec for the local jurisdiction or AHJ. Can enter code number from different model codes. Can even search for fire assemblies and get diagrams or drawings.
- UL Standards are developed similar to NFPA by having a committee that is made up of building and fire officials, builders, product manufacturers and many others.

- Fire Service membership council is free to sign up and you can receive information on codes.
- ICC is looking at going to online certification testing opposed to pencil and paper.

Notable events during reporting period:

Certificate of Deposit that was at Fulton Bank matured on December 6, 2015, and was cashed in and deposited into the checking account. The amount of the CD was \$29,058.85.

2015 Taxes were filed with IRS.

Association has obtained insurance on trailer, association assets, and events for the first time since its' existance. Cost was \$1,981.00

A new vendor was selected for hosting website and membership/conference management resulting in a significant cost savings. Approximately \$3,900 per year versus \$756.00.
